Treasurer's Report:

Carol provided copies of new format allowing for easier tracking of various categories.

CM Shearer explained that due to an accounting error, Shade Tree has not received it's total tax millage, however, the situation should be remedied this month. Future payments will be disbursed in January of the following year.

Arborist Report:

HWA problem, pros and cons of treatments, research being done. Conclusion is that residential setting infestations must be approached on a case by case basis. Resources for assistance are being approached. Cooperation of public is needed. Ways to engage are being considered.

Adopt a Tree Program for spring planting - resident has requested that the Arborist help with his tree selection. Process will be much the same as the 9 trees planted last year. Explained value of using local nursery

Explanation of why updating Code 220 was important and how current practices are influencing the advice of the shade tree commission to the residents for plantings, the role of the permit process, and the PennDot main street project.
