- 5.Motion to approve an addendum submitted by **Maher Duessel Certified Public Accountants** for auditing services for Fiscal Year 2024 through 2026 as outlined in their engagement letter of February 14, 2022, and to authorize the City Clerk to sign said letter on behalf of City Council. Second by CM Christy. All voted aye.

6. Motion to approve **Mariner Institutional's** recommended trades in the City's pension plans as requested from the Pension Board. Second by CM Herr. All voted aye.

- 7. Motion to approve the conditional hiring of **Derek S. Thompson** as a full-time Firefighter in the City of Butler Bureau of Fire. Second by CM Shearer. All voted aye.
- 8. Motion to approve the conditional hiring of **Jonathan R. Mann** as a full-time Firefighter in the City of Butler Bureau of Fire. Second by CM Shearer. All voted aye.

- 9.Motion for the second reading and adoption of **City Ordinance No.1827**; an ordinance increasing the indebtedness of the City of Butler, Butler County, Commonwealth of Pennsylvania, by the issuance of a General Obligation Note in the amount of \$1,000,000.00 for the general obligations of the City of Butler through 2024. Second by CM Shearer. All voted aye.
- 10.Motion to approve closing of E. Diamond Street from Main Street to McKean Street on Friday, February 21, 2025, from 9:00 AM until 5:00 PM, and the closing of Main Street from Wayne Street to Cunningham Street, and Diamond St. from Washington Street to McKean Street on Saturday, February 22, 2025, from 9:00 AM until 5:00 PM, for the **Carved in Ice Event**, sponsored by Butler AM Rotary Club. - 11.Motion to approve **City Council's 2025** meeting schedule, a copy of which will be published in a local newspaper to comply with the Sunshine Act and attached to the minutes of this meeting. Second by CM Shearer. All voted aye.
- 12.Motion to approve closing Main Street from Penn Street to Wayne Street and intersecting streets from McKean Street to Washington Street, beginning at 4:30 PM for approximately 2-1/2 hours, for the **Spirit of Christmas Parade** sponsored by Butler Radio Network, to be held on Saturday, November 30, 2024. Second by CM Christy. All voted aye.
- 13. Motion to approve the resignation of **Patrol Officer Kory L. Fleming**, following 8 years of service, effective November 3, 2024. Second by CM Herr. All voted aye.
- 14. Motion to approve the final closing documents related to the sale of the Butler Area Sewer Authority system to Pennsylvania American Water pursuant to City Resolution 2022-10-13A, approved October 13, 2022, subject to the Solicitor's approval of the closing and related documents. Further, the Mayor and City Clerk are hereby authorized to sign all documentation necessary to finalize the sale, including, but not limited to, the Wind-down Agreement between the City of Butler, the Township of Butler, and the Butler Area Sewer Authority. Second by CM Shearer. All voted aye.
