# City Council Meeting City of Butler, Pennsylvania March 27, 2025

Mayor Dandoy called the meeting to order at 7:00 PM. Mayor Dandoy and Council members Shearer, Christy and Herr were present. The pledge of allegiance to the flag followed an invocation given by Pastor Dwight Dunn, Westminster Presbyterian Church.

#### The following actions took place at the Forum Meeting held on March 13, 2025:

Mayor and Council met in an executive session to labor and legal issues at 6:30 PM prior to the Forum meeting. No action was taken.

There were no "Persons to be heard".

Motion by Mayor Dandoy to approve the agenda for March 13, 2025. Second by CM Shearer.

Motion by Mayor Dandoy to amend the agenda to add motions no. 2 through no. 7 (below). Second by CM Christy. All voted aye.

All voted aye. Agenda amended.

- 1.Motion to approve **City Resolution No. 2025-03-13**; for the project "City of Butler Emily Brittain Playground Rehabilitation Community Park Phase II." Motion by CM Herr. Second by CM Christy. All voted aye.
- 2.Motion to approve the recommendation of our consultant (5) and enter into the contract with **Freepoint** to be the City's electrical supplier for a period of 48 months beginning November, 2025 through December, 2029 at a contract rate of \$0.08330. # Mayor Dandoy made the following statement concerning Historic Pullman Park:

As we move forward, we appreciate your patience and support. These discussions will take time, and we are committed to keeping the community informed with regular updates as we explore the best path forward.
