# CITY OF BUTLER CODE CONSTRUCTION PERMITS

**\*The state of Pennsylvania** requires a \$4.50 UCC fee for each building or demolition permit. Permits other than these do not require the \$4.50 fee.

**Zoning Permits:** Zoning permits are issued for accessory structures such as sheds, garages under 1000 square feet, fences, carports, greenhouses etc. Zoning permits are \$60.00. The State UCC fee does not apply.

**A Plot Plan or a copy of a survey is required** for structures such as sheds, garages, additions, fences, carports, and any other construction that increases the footprint of the existing structures or requires a specific setback.

**Swimming Pools --** A permit is required for in ground or above ground swimming pools and **requires a plot plan.** The permit fee is based on the cost of work, and the State UCC fee applies. Please contact our office at 724-285-4124, Ext. 212 to discuss required information and fees. Electrical permits are also required for swimming pools.

Make checks payable to "City of Butler". Cash or checks only accepted. No credit or debit cards.
